Extension of Closing Date for Non-Renounceable Rights Issue

Bounty Oil & Gas N.L. (Bounty or the **Company**) advises that due to the Christmas/New Year break the closing date for the pro-rata non-renounceable rights issue of up to 374,625,245 fully paid ordinary shares (New Shares) on a 1 for 4 basis at an issue price of 0.4 cents per New Share to raise approximately \$ 1.5 million before costs (**Entitlement Offer**) has been **extended to Friday, 17 January 2025** to allow extra time for Eligible Shareholders to take up their entitlements.

The Entitlement Offer includes a shortfall facility under which eligible shareholders that have taken up their full entitlement under the Offer <u>can now apply to take up any number of</u> <u>additional New Shares in excess of their pro rata entitlement</u> (**Shortfall Offer**). The limit of up to 50% of entitlement will no longer apply.

Company Update

Funds from the Entitlement Offer will supplement ongoing oil production operations and development of Bounty's proved Surat Basin oil reserves and resources.

As advised on 17 December 2024, the CEO and Directors intend to take up their full entitlement, being approximately \$51,000 worth of shares.
